Our organization is entering 45 years of service. Rescuing, rehabilitating, and releasing wildlife remains our mission. In 2025, we treated 3,328 patients and saw 129 different species. Our staff answered 7,076 phone calls assisting the public with wildlife emergencies and offered educational resources to assist with wildlife conflicts and questions. We accept all species from anywhere in Washington state, but primarily received patients from Snohomish, King, Skagit, Pierce, Whatcom and Island counties. Our new wildlife hospital was completed in July, 2025.
